## Door Frame

This warranty is not intended to include the substrate to which the aluminum entry door cladding is applied, nor to any portion of the framework that the entry door or all-aluminum garage door frame is applied. Warranty of the entry door, the entry door wood frame, sill, side lites, transom, etc. is covered by the manufacturer of those products. This warranty applies to the original homeowner only, and owner occupied homes only. Home owner must supply proof of purchase. If the product is determined to be defective, FrontLine® Bldg. Products Inc. will, at its own option, offer one of the following:

- Repair the defective product
- Replace the defective product
- Refund purchase price
- If you chose to replace the product, FrontLine<sup>®</sup> Bldg. Products Inc. will not be responsible for any installation of the replacement product or removal of the effective product.
